MES, Hydrate, Bio Pharma Grade manufactured by BioSpectra conforms to the limits established in USP <232>, USP <233>, and ICH Q3D guidance for Elemental Impurities. Based on the manufacturing process and the controlled handling, storage, and analysis of this product, MES, Hydrate, Bio Pharma Grade complies with the requirements and specifications of the ICH Q3C Residual Solvents Guideline and USP <467> Residual Solvents.

BioSpectra does not specifically analyze MES, Hydrate, Bio Pharma Grade for genotoxic impurities, as they are not intentionally added or used in the BioSpectra manufacturing process.
